## Minister's Message



Telangana completes 9 years of its formation this June and its growth story so far has been a remarkable one of tremendous transformation including many successes and accolades. Under the able leadership of Hon'ble Chief Minister Shri K. Chandrashekar Rao, we were able to become a power surplus state from a power deficient one, and a pioneer in areas such as innovation, industrial & IT growth and agricultural produce.

Our capital city of Hyderabad is now being ranked as one of the top global cities on several parameters such as dynamism, quality of living, greenery etc. For instance, Hyderabad ranked No. 1 most dynamic city in the 7th edition of JLL's City Momentum Index (CMI) 2020 amongst 130 cities across the globe. The World Economic Forum ranked Hyderabad as the World's 2nd most dynamic city after evaluating 30 global cities in 2020. Hyderabad retained top ranking amongst Indian cities in Mercer's 21st quality of Living survey in 2019, 5th year in a row. Hyderabad City bagged the prestigious World Green City Awards 2022 by International Association of Horticultural Producers (AIPH).

We are also one of the leading States in the country in Ease of Doing Business (EoDB) for past several years. Recently, Telangana was selected in India's 'Top Achievers' category in the implementation of the Business Reforms Action Plan (BRAP) 2020. Telangana has also emerged as the best performing state in promoting inclusive and sustainable economic growth and decent work for all on NITI Aayog's Sustainable Development Goals (SDG) India Index 2019.

Telangana's innovative initiatives such as T-Hub, We-Hub, TSIC, T-Works and RICH have enabled our state to become one of the 'Top Performers' in the States' Startup Ranking, 2021 released by Department for Promotion of Industry and Internal Trade (DPIIT). Telangana has also ranked No. 2 in India Innovation

Index 2021. Other initiatives of TASK and TIHCL have been recognized across the country as unique and replicable models. TIHCL concept has also been included in the revised GoI industrial policy draft.

Telangana through its flagship initiative of TS-iPASS has attracted 22,745 industries so far, investments of Rs. 2,60,060 Crs. and created employment for 17.54 lakhs people. Telangana State Industrial Infrastructure Corporation (TSIIC) has developed 109 new Industrial Parks on 35,581 acres of land during FY. 2014–23.


Telangana's priority sectors have been showing exemplary performance in terms of attracting new investments and employment generation. The Life Sciences sector has attracted investments worth 25,000 Crs. with employment generation of more than 4.5 lakhs since 2014. The Food Processing sector has generated investments of Rs. 6,864 Crs. leading to establishment of 3,807 units, and creation of 80,000 employment opportunities since 2014. Telangana in Aerospace & Defence sector won the Best State Award from Ministry of Civil Aviation consecutively for the third time in a row (2018, 2020, 2022), for being the Indian State with the most forward outlook towards Aerospace & Aviation sector and as one of the most cost-effective global aerospace hubs. Under EV sector, Telangana Mobility Valley (TMV) which is India's first and one-of-its-kind New Mobility focused cluster was launched in February 2023 during Hyderabad E-Mobility Week. TMV aims to attract investments of Rs. 50,000 Crs. and generate more than 4 lakh jobs in the next 5 years. In the last nine years, Handlooms & Textiles sector has attracted total investments of Rs. 6,496 Crs. with employment potential of 43,370 people.

As Telangana embarks on the 10<sup>th</sup> year of its growth and development, I wish to thank and congratulate all those who have been a part of the growth story of this Start-up State. I look forward to full support from all industries, associations and other important stakeholders so that in the coming years we can make Hyderabad and Telangana shine on the Global map.

### Growth Rate of GDP vs GSDP at Current Prices for India and Telangana





### Year-on-year GSDP vs GDP at constant prices (in Rs. Crs.)




### **Number of Approvals given under TS-iPASS**







- Almost 2 Mn sft of lab space has been added during the last 3 years in Genome Valley. The cluster houses the largest concentration of international standard multi-tenanted lab space for any cluster / city in the country
- BioAsia has emerged as the marquee Life Sciences event globally, gaining tremendously in prestige. Over the last years, many influential global leaders like Mr. Bill Gates, Mr. Alex Gorsky (Chairman, J&J), Mr. Vas Narsimhan (CEO, Novartis), Mr. Geoff Martha (Chairman and CEO, Medtronic), Mr. Satya Nadella (CEO, Microsoft), among others have participated in the event

# New Initiatives Launched to accelerate growth in Life Sciences



Medtech park: Medical Devices Park established in 2017, has become India's biggest functional medical devices cluster offering facilities that support innovation, research & development, manufacturing as well as warehousing and logistics. About 55 companies are setting up their R&D and Manufacturing facilities in the park, generating over 7,000 jobs and attracting over Rs. 1500 Crs. of investments. The park is home to the Asia's largest stent manufacturing facility of SMT. Further, Medtronic has one of its largest development centers in Hyderabad and with the recent announcement it has invested half a billion USD in Hyderabad.



Biopharma Hub: Foundation stone laid for Biopharma Hub (B-Hub), a first-of-its-kind Growth-Phase Centre and Biopharma Scale-up Mfg. facility, in Genome Valley

Flow Chemistry Hub: Flow Chemistry Lab set up by Government of Telangana in collaboration with Dr. Reddy's Laboratories and Laurus Labs to help Pharma companies transition to cleaner and advanced manufacturing processes.

**C4IR:** Government of Telangana forged partnership with World Economic Forum to set up C4IR Telangana. A first of its kind, C4IR will help advocate on policy & governance for healthcare and life sciences. This is India's first centre thematically focused on healthcare and life sciences, in Hyderabad.



Hyderabad Pharma City -World's pharmaceutical cluster with best in-class utilities. Hyderabad Pharma City offers significant cost and set-up time optimization for the pharma industry with its centralized smart infrastructure solutions. HPC will provide a jumpstart platform to Life Sciences companies and help companies move-up the value chain. It is expected to attract Investment worth USD 9.7 Bn and generate employment to the tune of 560,000 people.

**Life Sciences University:** Envisaged establishment of a world class Life Sciences university. Partnership was forged with King's College London to jointly develop and deliver master's programme starting 2024. Similar partnership is being explored with world renowned institutes like Broad Institute, Scripps, Carnegie Mellon, etc.

AMR CoE: We are establishing a first of its kind world class Antimicrobial Resistance (AMR) Centre of Excellence (CoE) which will help build the capabilities of industry and government to adopt sustainable antibiotic manufacturing monitoring and technology solutions.





Multimodal Logistics Park in Medak by Telangana -Gateway for cargo, connecting India: Telangana State Trade Promotion Corporation (TSTPC), NHLML and Rail Vikas Nigam Ltd have entered an MoU to establish a world class logistics facility in Medak. (2022)



Telangana is one of the primers to introduce a dedicated Logistics Policy in 2021 for promoting the sectoral investments and one of the first to accord industry status to the sector alongside creating a dedicated division



Amazon unveiled its largest fulfilment center in Shamshabad near Hyderabad. Covering over 400,000 square feet with close to 2.1 million cubic feet of storage space, the center is the fifth fulfilment centre in Telangana and the largest in India.

- Established a Container Freight Station in an area of 7.01 acres at Mamidipally, Opp. to Hardware Park, near RGI Airport, Hyderabad for the use of trade and industry in Hyderabad and surrounding districts for the purpose of bonding and debonding their export / import cargo, Customs clearance, stuffing and de-stuffing of containers etc. Necessary action has been taken to make it operational by appointing an O&M Operator

## **Sugar Department**

### **Department of Sugar**

Department of Sugar has been working for self sustenance & also to achieve the objectives of New Biofuel policy, 2018. In this regard, the Department has taken steps for improving Production of Sugarcane, Sugar, Biofuel, etc., and diversification of sugar industry for promoting New distilleries & Expanding existing distilleries under the new policy of Government thereby strengthening the sugar industry & stabilising the farm income of rural community and sustenance of sugarcane cultivation in Telangana. Sugar industry

is the only source to drive different ancillary industries such as Confectionary, Beverages, Food processing & some extent in transport, farm machinery etc.

The Sugar industry is an important major agro-based industry that impacts rural livelihood & generating employment to not less than 30000 & contributing Taxes to the Central and State exchequers.

The government of India has set a target of 43 Crs. Ltrs of Ethanol to be supplied by Telangana state towards Ethanol Blending Petrol Program so as to reach 20% blending by 2025.

The state requirement of sugar is 7.42 Lakh MTs. (18.5 Kg X 4.01 Crs. population), & the balance sugar requirements is being met from the neighbouring states.

The Sugar department is enforcing various Central and state Acts & rules and ensured cane price

payment. Department encouraged farmers for sugarcane plantation by supplying various inputs & infrastructural developmental activities on subsidy basis through Cane Development Councils in the factory zones. Sugar mills are also encouraging farmers with subsidies, incentives, loans etc., to increase the cane areas in their jurisdiction.

### **Policies-Schemes**

Sugar Department has implemented in the sugarcane zone areas in coordination with sugar mills such as; Farm mechanization in Sugarcane: Towards assistance to CDCs for systematic sugarcane intensification for farm mechanization in sugarcane has implemented during 2014-15 and 2015-16. Later it has transferred to Agri Dept. i.e., Nodal agency for Farm Mechanization & it helps in mitigating the labour requirements in cultivation besides improving quality of sugarcane.

#### **Schemes**

Assistance to Cane Suppliers as Purchase Tax Incentive: As per section-21 of TS (RS&P) Act, 1961, the purchase tax is levied @ Rs. 60/- per MT of cane purchased by the sugar factories, since 2001-02 the purchase tax payable to the government is being passed on as an incentive to the cane suppliers due to non declaration of State Advised Price and in order to give remunerative price to cane growers uniformly by the State Government to all the Sugarcane Growers. Later due to implementation of GST, the Purchase Tax was subsumed in to GST and the Scheme was discontinued from 2016-17 season onwards.

### **Cane Development Councils (CDCs)**

CDCs are functioning in each factory zone to ensure the timely supply of inputs, loans & other incentives for needy cane farmers towards cane development in factory zones as part of improving cane area & sugarcane production and encourage farmers to bring new areas under sugarcane cultivation by providing Seed, Harvest & Transport subsidies in Cane Production such as Seed subsidies, transport subsidies etc., with an annual budget of Rs. 1.60 Crs. to 2.00 Crs.

### **Recent Trends**

Under new Biofuel policy for Ethanol Blending Petrol program large number of project proponent's approaching government for setting up of new distilleries, from which 31 projects (6212 KLPD) with annual production of 186.39 Crs. Liters approved in principle by DFPD, GOI by recommending for loan amount of Rs. 4614.00 Crs. Some distilleries also directly approached Govt of Telangana with annual production capacity of 19.44 Crs. Liters.
